**“Conflict minerals” and “Conflict metals” compliancy statement for Nyrstar’s metal products zinc, zinc alloys, lead, lead alloys, cadmium, copper, precious metals (silver, gold) and sulphuric acid, originating from:**

Dear valued customer,

Nyrstar hereby declares that it does not purchase cassiterite, columbite-tantalite, wolframite or any of their derivatives from the Democratic Republic of Congo (“**DRC**”) or an adjoining country (hereafter “**conflict minerals**”).

Nyrstar equally does not purchase gold (Au), tantalum (Ta), tungsten (W) or tin (Sn) from the DRC or an adjoining country (hereafter “**conflict metals**”).

None of our metal products being zinc, cadmium, copper, precious metals and their alloys or our sulphuric acid product, contain added metals gold (Au), tantalum (Ta), or tungsten (W).

Some of our batch galvanising alloys and lead alloys do contain added tin (Sn) in metal form. The tin (Sn) in metal form is not purchased in the DRC or an adjoining country. However, Nyrstar does not, within its organization, possess the capability to trace, with certainty, the origins of the mineral concentrates for the production of this tin (Sn) in metal form. Nyrstar however endeavours to use commercially reasonable efforts, via a supplier declaration process, to verify the source of the minerals which are incorporated into the purchased tin (Sn) in metal form and endeavours to seek those sources that can assure that conflict minerals are not incorporated in its purchased tin (Sn) in metal form.

Should Nyrstar consider purchasing raw materials from the DRC or an adjoining country, such as but not limited to secondary zinc oxides or lead oxides, it endeavours to undertake a risk assessment to ensure, within its organizational capability, that such raw materials do not contain conflict minerals or conflict metals.

This statement replaces all previously issued statements on conflict minerals and conflict metals.
